

The project « SOLIDARITY » was funded with the support of the European Union under the Programme "Europe for Citizens" "Civil Society Projects"

9 events have been carried out within this project:

Event 1

Participation: The event involved 46 citizens, including 4 participants from Poland, 2 participants from Germany, 40 participants from France.

Location / Dates: The event took place in **Lille, France**, from 03/10/2018 to 05/10/2018

Short description: The aim of the event was to launch the SOLIDARITY Tour on a Weimar Triangle model, by gathering young people coming from France, Germany and Poland to discuss thematic of importance for European youth (education, integration in the labour market and mobility in particular).

Event 2

Participation: The event involved 51 citizens, including 4 participants from Belgium, 7 participants from France, 3 participants from Czech Republic, 4 participants from Hungary, 4 participants from Greece, 4 participants from Serbia, 29 participants from Poland.

Location / Dates: The event took place in **Warsaw, Poland**, from 13/02/2019 to 15/02/2019

Short description: The aim of the event was to gather young citizens for them to discuss and issue recommendations about the future of work, within workshops and in front of an expert panel.

Event 3

Participation: The event involved 47 citizens, including 4 participants from Poland, 3 participants from Belgium, 4 participants from Greece, 7 participants from France, 3 participants from Serbia, 4 participants from Hungary, 22 participants from Czech Republic.

Location / Dates: The event took place in **Prague, Czech Republic**, from 10/04/2019 to 12/04/2019

Short description: The aim of the event was to gather young citizens for them to discuss and issue recommendations about different European thematic (democracy, values and future of the EU, immigration issues, opportunities for young people), within workshops and in front of an expert panel.

Event 4

Participation: The event involved 33 citizens, including 4 participants from Poland, 2 participants from Belgium, 6 participants from France, 4 participants from Serbia, 2 participants from Greece, 3 participants from Czech Republic, 12 participants from Hungary.

Location / Dates: The event took place in **Budapest, Hungary**, from 18/09/2019 to 20/09/2019

Short description: The aim of the event was to gather young citizens for them to discuss and issue recommendations about the integration on the labour market, within workshops and in front of an expert panel.

Event 5

Participation: The event involved 51 citizens, including 4 participants from Poland, 6 participants from France, 1 participant from Belgium, 3 participants from Czech Republic, 3 participants from Hungary, 4 participants from Serbia, 32 participants from Greece (including refugees / asylum seekers living in Athens).

Location / Dates: The event took place **Athens, Greece**, from 16/10/2019 to 18/10/2019

Short description: The aim of the event was to gather young citizens for them to discuss and issue recommendations about the immigration and asylum policy, within workshops and in front of an expert panel.

Event 6

Participation: The event involved 53 citizens, including 33 participants from Serbia, 4 participants from Hungary, 3 participants from Czech Republic, 5 participants from France, 1 participant from Belgium, 4 participants from Poland, 3 participants from Greece.

Location / Dates: The event took place in **Belgrade, Serbia**, from 06/11/2019 to 08/11/2019

Short description: The aim of the event was to gather young citizens for them to discuss and issue

recommendations about the EU's enlargement, especially in the Balkans, within workshops and in front of an expert panel.

Event 7

Participation: The event involved 110 citizens, including 4 participants from Poland, 3 participants from Greece, 3 participants from Czech Republic, 1 participant from Belgium, 4 participants from Serbia, 4 participants from Hungary, 7 participants from Germany, 84 participants from France.

Location / Dates: The event took place in Paris, France, from 17/12/2019 to 19/12/2019.

Short description: The aim of the event was to gather young citizens for them to discuss and issue recommendations about the four main thematic of the SOLIDARITY Tour (integration in the labour market, regional and international mobility, asylum and immigration, democratic participation), within workshops and in front of an expert panel, at a larger scale for the final conference of the project. It also aimed at advertising the manifesto and methodology guide produced following the project.

Event 8: Manifesto

Participants: 54 people were involved in the development of the Manifesto. They came from 9 countries: Poland, Czech Republic, Hungary, Greece, Serbia, France, Belgium, Portugal and Slovakia. The manifesto was finalized at the end of the program, at the end December 2020, in Paris.

Short description: A Manifesto was drawn up with the main recommendations and proposals of the young Europeans. This manifesto was published on the Confrontations website and sent to all participants, partners and stakeholders of the project. It was also presented and/or sent to MEPs, members of the European Commission, members of the CES, local and national elected representatives and civil society organisations in order to convey our messages. The manifesto will continue to be actively relayed by Confrontations Europe and its networks to ensure that some of the recommendations are taken up and implemented by decision-makers.

Event 9: Methodological Guide

54 people were involved in the development of the Methodological Guide. They came from 9 countries: Poland, Czech Republic, Hungary, Greece, Serbia, France, Belgium, Portugal and Slovakia. The Guide was finalized in the last week of December 2020, in Paris.

Short description: The Guide has been produced to present the genesis of the Solidarity project, to value the voice of young European citizens and to present their stories, testimonies and concerns. The Guide also presents the means of communication used to carry the voice of these young Europeans.

Preparatory activities

24 people participated in the Preparatory Activities. They came from 9 countries: Poland, Czech Republic, Hungary, Greece, Serbia, France, Belgium, Portugal and USA.

Short description: The Preparatory Activities allowed the elaboration of the solidarity programme, the definition of the themes, the means of communication, the setting up of the different events and all the administrative details useful for the good implementation of the project in the different countries.
